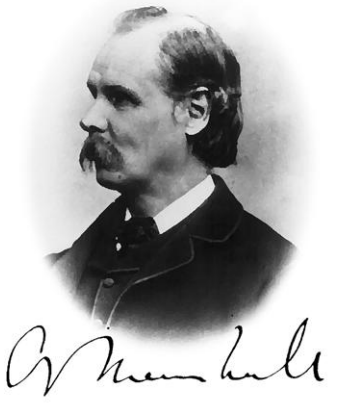

Content	
Summary	Lists laws of the society and detailed minutes from the inaugural meeting onwards. The aims were to bring together all members of the University and the women's colleges who were interested in social questions, to increase an interest in such questions and study them unbiased by political or religious prejudices. The first speaker was Henry Morris, Cambridgeshire Educational Officer on 'Modernism and Education'. Mary Paley Marshall was one of the Honourary Vice-Presidents. The Society initially met in The Marshall Library and had 119 members by the Easter Term 1927. It had two main interest groups: economics and industrial welfare and education. These later changed. Minutes give names of officers, speakers etc. and summaries of lectures. Later speakers of note include John Maynard Keynes 'The Causes of the Slump' (25 May 1931) and 'The Economic Outlook 1932' (11 Feb 1932), A.P.L. Gordon of The British Union of Fascists 'The Economics of National Organisation' (27 Oct 1932), Maurice Dobb 'The Marxian Theory of Imperialism' (10 Feb 1934), Maisky, the Russian Ambassador, on 'Economic Planning in Russia' (24 Jan 1935). First debate held 2 Mar 1938 on The Coal Bill and Nationalisation.
Free field	Committee meeting of 3 Dec 1930 resolved that minutes of Economics section were to be kept in a separate volume, now missing. Mary Paley Marshall was suggested as a speaker for Easter Term 1930, but no official record survives of her talk on working with Alfred Marshall.
